MIECF - A Regional Platform for Effective Exchanges in Environmental Protection

The Macao International Environmental Co-operation Forum & Exhibition (MIECF) is hosted by the Government of the Macao Special Administrative Region of the People's Republic of China, and co-organised by the governments of the Pan-Pearl River Delta Region (PPRD). The special supporting organisations include the National Development and Reform Commission of the People's Republic of China, the Ministry of Science and Technology of the People's Republic of China, the Ministry of Industry and Information Technology of the People's Republic of China, and the Ministry of Ecology and Environment of the People's Republic of China.

Since its debut in 2008, MIECF has seen continuous improvements and was accredited by the Global Association of the Exhibition Industry (UFI) in 2011. MIECF brings together a series of professional international forums, exhibitions, business matching and networking activities, in which both local and overseas participants take part. By organising high-level delegations to take part in the event, it promotes international co-operation among governments, industries, universities, research institutes, users and investors in the environmental protection area. MIECF aims to grow into an international exchange and co-operation platform that promotes technology transfer and sustainable development for the environmental protection sector in the "Belt and Road" countries and regions, the Pan-Pearl River Delta Region (PPRD), the Guangdong-Hong Kong-Macao Greater Bay Area, Portuguese-speaking countries, European countries and the rest of the world.

Theme: Towards a Green and Low Carbon New Era

Green and low carbon development is not only a globally discussed issue concerning the implementation of the Paris Agreement, but it is also a key to China's future development and a priority for countries and regions along the "Belt and Road" Initiative to achieve common development. With the theme "Towards a Green and Low Carbon New Era" and through case analysis, policy analysis, technology demonstrations and business networking, this year's MIECF will, jointly with the participants, promote "dual circulation" – a new green economic development pattern – in pursuit of a new green and low carbon era.

MIECF Participants' Stories

Exhibitor from Yunnan province: "Through MIECF, we were exposed to new environmental protection concepts, and trends in the development of environmental protection technologies in Portuguese-speaking countries, Hong Kong and Macao. We also understood how much we fall short. However, the exhibition allowed our counterparts from different countries and regions to learn about the research capabilities of our provincial Institute of Ecological and Environmental Science, and technological advantages in environmental conservation for plateau lakes. Some overseas enterprises and research institutes are interested in co-operating with our province."

Exhibitor from Zhuhai, Guangdong province, engaged in industrial waste heat recovery and building energy-saving technologies: "Through MIECF, we have raised our brand awareness and many quality customers have approached us for business meetings. More than ten potential agents hope to represent our products in the three major areas – solar photovoltaic, solar water heating and energy-saving buildings."

Exhibitor from Portugal: "MIECF enables companies to enter the mainland China market and attract overseas capital to develop their business. Two Portuguese companies have successfully matched with mainland investors, so we are very pleased with the outcome of joining MIECF."

Macao-based exhibitor at MIECF "Greenovation Zone": "We received enquiries from different regions (Mainland China, Hong Kong and Taiwan region) when we participated in the event for the first time, in addition to enquiries from local large hotels about our new environmental protection products. The results from taking part in MIECF have far exceeded our expectations."

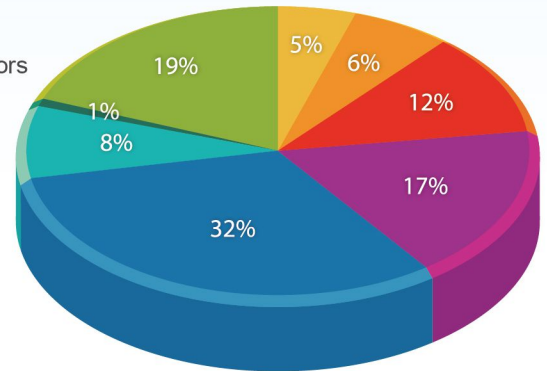
